The candidates are called for documents verification based on the particulars furnished in their online applications such as age educational qualification, caste status etc. The provisional selection of candidates will be made only after verification/acceptance of certain documents, education qualification possessed by him/her, clarification regarding caste status and its acceptance, marks/rank list of the candidate etc. as the case may be. If any of their claims are found to be false or incorrect, their candidature is liable for rejection at any point of time.
5. Candidate called for Documents Verification is hereby advised to appear with all the relevant documents in original without fail. Failure to produce even any one of the essential documents will result in rejection of his/her candidature.

SC/ST/PWD candidates are given Slipper Class Rail /Ordinary Bus fare (fro and to) by the shortest route (not less than 30 km.) to examination centre for appearing in Documents Verification as well as Skill /Typing Test on production of valid ticket through e-payment module.
