1	It is learnt that NWDA put up a proposal to introduce its own CPF rules on the lines of Central Govt. CPF Rules 1962 in the 3 rd GB meeting as an agenda of the meeting for approval by GB. In this context the enclosure of the agenda (CPF Rules 1982) and the following information may please be provided. In the year October, 1992 the Department of Pensions & Pensions Welfare issued ng O.M. No. 20(15)-P&PW/90-E dated 7-10-1992 enhancing the rate of subscription/govt. contribution from 8.33% to 10% w.e.f. 01-03-1992 in respect the employees governed by CPF rules 1962. Since NWDA says that it follows the alleged CPF rules 1982 of its own, it cannot implement the enhancements of the rate of subscription straightway on the basis of said O.M. It is protocol that if any amendment is take place in CPF rules 1962, the same should be placed in the GB meeting in which the proposal of enhancement of rate of subscription/contribution was placed, the copy of the agenda and minutes approving the enhancement by GB may please be provided.
