Whereas, the Central Government has notified the constitution of Ken Betwa Link Project Authority, as a vertical of National Water Development Agency vide notification no. N-67037/4/2018-BM dated 09.02.2022. Now, therefore, in exercise of the powers conferred by the Rule 21 of the Memorandum of Association, Rules and Regulations and Bye-Laws of NWDA, the Central Government, in partial modification of the existing Recruitment Rules for the posts of Additional Chief Executive Officers issued on 05.09.2022, hereby makes the following rules regulating the method of recruitment to the posts of Additional Chief Executive Officers namely:-


1. **Short title and commencement:-** (i) These rules may be called the Ken-Betwa Link Project Authority, Additional Chief Executive Officers (Canals, Environment, R&R and Land acquisition, Elect & Mech and Head Works) Recruitment Rules, 2023.
(ii) They shall come into force with immediate effect.
2. **Application-** These rules shall apply to the post specified in Column (1) of the Schedule annexed to these rules.
3. **Number of posts, their classification and scale of pay-** The number of the said posts, their classification and scales of pay attached thereto, shall be as specified in column (2) to (4) of the Schedules annexed to these rules.
4. **Method of recruitment, age limit, qualifications, etc. -** The method of recruitment, age limit, qualification and other matters relating to the said posts shall be as specified in columns (5) to (13) of the Schedule.
5. **Disqualification – No person-**
 - a. Who has entered into or contracted a marriage with a person having a spouse living,

Or
 - b. Who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to any of the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. **Power to relax** – Where the Central Government is of the opinion that it is necessary or expedient to do so; it may, by order and for reasons to be recorded in writing and with the approval of Minister (Jal Shakti), relax any of the provisions of the rules with respect to any class or category of persons.

7. **Saving-** Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for persons belonging to the Scheduled Castes. The Scheduled Tribes, the Ex-Servicemen. Other Backward Classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
