Apart from this, Members of the Group, after deliberations, decided following points for making improvement in the report:

- (i) Section-IV (Work done by the Group) should be deleted as many things discussed in this section are of repetitive nature. Thus the Report will now have only four Sections.
- (ii) International Experiences on Inter Basin Water Transfer, particularly of China, Colorado, Japan, Egypt, etc. should be added in the Final Report.

- (iii) Material given by Prof. Avdhesh Pratap, Member of the Group on three judgements of Supreme Court of USA should be suitably included in the report, explaining its technical background.
- (iv) Summary of the Report should be modified in view of addition of recommendations.
- (v) Modified draft report prepared by NWDA should be circulated among the Members preferably on 3rd March, 2017 which would be discussed in the Ninth Meeting of the Group proposed to be held on 9th March, 2017 and finalised for submission.

Item No. 8.3 Any other item (s) with permission of the chair

Chairman of the Group expressed the hope that the report would be finalised in next meeting to be held on 09.03.2017. As such he requested the Members to go through the content of the entire report before coming for the next meeting and suggest last minute changes, if required, at any place.
