Sub: Appointment of Smt. Y. Gopi Lavanya, Dy. Executive Engineer on deputation on Foreign Service basis as Dy. Director/ Executive Engineer in NWDA.

Sir,

I am directed to refer to your letter No.Rc/ENC(Admn.)/C1/23022118/2023 dated 03.03.2023 and to say that the Competent Authority has approved appointment/selection of Smt. Y. Gopi Lavanya, Dy. Executive Engineer of your organization, to the post of Dy. Director/ Executive Engineer in Level-11 of Pay Matrix (Rs.67700-Rs. 208700/-) in NWDA on deputation on foreign service basis on the following terms and conditions:-

- **Period:** Three years from the date Smt. Y. Gopi Lavanya, Dy. Executive (i) Engineer is relieved from her duties in his parent department provided that she joins NWDA within the permissible joining time in terms of the provisions contained in DOPT's OM No. 6/08/2009-Estt (Pay-II) dated 17.6.2010 as amended from time to time. However, the services of SSmt. Y. Gopi Lavanya, Dy. Executive Engineer, as and when a situation arises can be reverted to his parent department before completion of normal period of deputation.
- (ii) **Pay:** During the period of his foreign service, she will have the option as follows:

OR

- (a) to get her pay fixed in the pay scale attached with the post held on foreign service subject to the provisions contained in the DoPT's OM No. 6/08/2009-Estt (Pay-II) dt. 17.6.2010, as amended from time to time.
- (b) to draw the pay of the post held by her in his parent department plus deputation (duty) allowance in accordance with and subject to the provisions contained in DOPT's OM No. 6/08/2009-Estt (Pav-II) dated 17.6.2010 as amended from time to time.

The option once exercised shall be final subject to the provisions contained in para 4.3 of the DOPT's OM No. 6/8/2009-Estt (Pay-II) dated 17.6.2010 as amended from time to time.

- (iii) **Dearness Allowance/HRA:** She will be entitled to draw Dearness Allowance/HRA as per the Central Government rules if she opts to draw pay of deputation post. If she opts to draw her grade pay plus deputation (duty) allowance, she will be entitled to draw these allowances as applicable in his parent department.
- (iv) **Joining time, joining time pay & Transfer Travelling Allowance:**She will be entitled to travelling allowance, joining time pay and joining time, both on joining the post on transfer on Foreign Service and reversion there from to the parent department under the rules applicable in NWDA.
- (v) **Travelling allowance for journeys on duty during the period of deputation:** As admissible to officers of equivalent grade under the rules applicable in NWDA.
- (vi) **Leave and Pension:** During the period of his deputation on Foreign Service, she will continue to be governed by the leave and pension rules of the lending organization applicable to her before such transfer.
- (vii) Leave Salary & Pension Contributions: NWDA will pay leave salary and pension contributions to the lending organization in respect of his foreign service at the rates in force from time to time. The rates and head of account will be intimated by the Pay & Accounts Officer of the parent department directly to the NWDA. The contribution will be paid annually within 15 days from the end of each financial year or at the end of Foreign Service of the deputation.
- (viii) **Provident Fund:** During the period of his deputation, she will continue to subscribe to the Provident Fund of the lending organization to which she may be subscribing at the time of her transfer in accordance with the rules of such fund.
- (ix) **Leave Travel Concession:** As admissible to NWDA employees from time to time. The cost thereof will be borne by the NWDA.
- (x) **Children Education Allowance:** During the period of deputation Smt. Y. Gopi Lavanya will be eligible to claim reimbursement of the Children Education Allowance as per the Government of India Rules.
- (xi) **Medical Concessions:** Smt. Y. Gopi Lavany will be entitled to these concessions under the rules of NWDA.
- (xii) **Residential Accommodation:** No free house or free car will be allowed, nor any conveyance will be provided at the expenses of NWDA.
- (xiii) **Commencement of Foreign Service:** The period of his foreign service will commence on the date on which she hands over charge of the post held in the parent office and will expire on the date on which she assumes charge of Contd...3/-

- the post in his parent office provided that she joins duty within the prescribed time limits of joining time.
- (xiv) Smt. Y. Gopi Lavanya should note that it will not be possible to agree for any request for change in terms & conditions of deputation on Foreign Service. However, other conditions of service will be same as decided by Govt. of India vide O.M. dated 17.06.2010 as referred to above and as amended from time to time.
- (xv) It is confirmed that her appointment to the post of Dy. Director/ Executive Engineer in NWDA on Foreign Service is exempted from the condition of permanent absorption.
- 2. In case, Smt. Y. Gopi Lavanya accepts the terms and conditions as detailed above, she may be relieved with the direction to report for duty to the O/o Superintending Engineer, Investigation Circle, NWDA, H. No. 5-2-68, 1st Floor, Markfed Bhavan, Jambagh, Putilibowli Post, Hyderabad (Telengana)-500001 within 30 days from the date of issue of this letter.
