Ken-Betwa Link Project

Background

A tripartite MoU for the preparation of Detailed Project Report (DPR) of Ken-Betwa Link Project was signed amongst the Union of India, Governments of Madhya Pradesh and Uttar Pradesh on 25.8.2005. The DPR of Ken-Betwa Link Project Phase-I was completed by National Water Development Agency (NWDA) and in April, 2010. Subsequently, DPR for Phase-II of the project was completed in January, 2014. A tripartite Memorandum of Agreement (MoA) for implementation of the Ken-Betwa Link Project was signed by the Hon'ble Chief Ministers of Madhya Pradesh and Uttar Pradesh and Hon'ble Minister for Jal Shakti on 22.03.2021 in the august presence of Hon'ble Prime Minister of India.
